Terms & Conditions

These Terms and Conditions (as amended, restated, supplemented or otherwise modified from time to time) govern the Melbourne City FC Member Get Member Program (the "Program"). The Program is a referral program run by Melbourne City Football Club ("the Club") whereby eligible club season ticket members (each, a "Member") can refer a third party ("Referred Party") to purchase season tickets to receive a referral point which can be redeemed for the below Rewards at the end of the Competition Period.

By participating in the Program, you agree that the following terms and conditions apply:

- 1. The Competition Period will run from 1 September 2018 to 31 December 2018.
- 2. Points will be redeemable from 1 January 2019 to 30 April 2019.
- 3. To be an Member eligible to collect points, you must hold a membership within one of the following categories: City Class, First Touch, City Gold, City Silver, City Blue, City General Admission, City Traveller ("an Eligible Membership").
- 4. For an eligible Member to receive a point for a referral, the Referred Party must:
 - (a) purchase an Eligible Membership within the Competition Period, and
 - (b) at time of purchase, identify the referring Member (either in the online field provided or to the membership team member over the phone).
- 5. Referring Member's details will be used to administer the Program and in accordance with the Club's member Privacy Policy.
- 6. If a Referred Party purchases a City Family membership, then two referral points will be credited to the referring Member's tally.
- 7. The Referred Party must be a first-time member of the Club. The Club may determine this in its sole discretion.
- 8. The referral points will be credited to the referring Member after the Referred Party has either (a) paid in full; or (b) if the Referred Party elects to pay by the Monthly City Opt-In program, when the first installment has been paid in full.
- A Member may not assign or transfer any referral points to another Member or entity without prior written consent of the Club. Any assignment in violation of this clause will void the points in question.

Major Prize

- 10. The Member with the most referral points at the end of the Competition Period will be the Major Prize Winner ("the Winner").
- 11. The Major Prize is a trip for two people to the Sydney FC vs Melbourne City FC, Round 22 A-League fixture, to be played at the Sydney Cricket Ground on Saturday 16 March 2019. The Major Prize package will include two (2) return economy flights from Melbourne to Sydney, one night twin share accommodation at a four-star hotel within 20km of the match venue, and two Premium A tickets to the match. The package is valued at \$1,500.
- 12. In the instance that the above fixture is cancelled or the Winner notifies the Club that they are unable to attend when the Prize is awarded, the Major Prize package may be substituted for a trip of equal value to another interstate fixture to be agreed by the Member and the Club.
- 13. The Major Prize is not redeemable for cash and may only be transferred with the consent of the Club.
- 14. If, at the end of the Competition Period, more than one Member has the equal highest number of referral points, the Winner will be the person who recruited the highest dollar value of referred members. Where the highest number of referral points and highest dollar value are the same, the Winner will be the first person to reach the highest number of referral points.
- 15. The Winner will be announced on the Club website www.melbournecityfc.com.au and notified by phone and email on 7 January 2019.

Rewards

16. Between 1 January 2019 to 30 April 2019, all participating Members can redeem their referral points for one or more of the following Rewards:

- 19. Any points not redeemed before 1 May 2019 will become void.

General
